

Minutes of the Full Council Meeting held on Wednesday 12th November 2025 at 7.00pm in the Council Chambers, Village Hall, Mansfield Road, Edwinstowe. Public and Press welcome to attend.

MINUTES

25/093 Welcome by the Chair

The Chair opened the meeting, welcomed all present and asked if anyone was recording. Cllr K Peck was recording.

The Chair commended the Edwinstowe Branch British Legion on this year's Remembrance Parade. It was very well attended by the Village and an important annual event. The Parish Council supports the parade and will continue to do so.

Cllrs Brooks, J Peck and K Peck attended the funeral of David Benham who had previously served on this Parish Council.

Cllr K Peck proposed an amendment to 88 (iv) to state, 'these were found to be unfounded.' **Agreed unanimously**

25/097 Matters Arising – not on the agenda

The streetlight issue on Newbery Close has now been resolved.

25/098 Report from County Councillor (5 minutes) – commenced 1904hours

C/Cllr Gamble gave his report mostly about matters not directly connected to Edwinstowe apart from the public bridleway from the new school at Thoresby

Vale linking the village and casework with residents. One issue was a new fence by the River Maun; the other was leaves on the roads. Concluded 1908hrs

Report from District Councillors (10 minutes) – commenced 1909 hours

D/Cllr Peacock reported on the Local Government Reorganisation – the preferred option is to split Nottinghamshire into Sherwood Forest Unitary Authority and Greater Nottingham Unitary Authority. The decision from Government is due in July 2026. The Parish Council need to resolve any District Council issues asap.

NSDC has purchased drones which can be used by Town and Parish Councils.

A local transport plan is being launched by East Midlands Combined County Authority. There will be a consultation from 17th November.

Harworth Estates are working on the sequencing of the A614/A6097

Working with NCC colleagues to try and lift the s106 restriction on Thoresby Vale to allow them to market the employment land and build further housing.

D/Cllr Brooks to raise the fence query at District Council on Thursday (13.11). Concluded 1919hrs

Resident requested the £1k of allotment holders rent that was used for the allotment road to be reimbursed to allotment holders. **Clerk to investigate and reply to resident**

Resident has previously reported speeding vehicles on Greendale Avenue to the C/Cllr Gamble and is troubled at the lack of response. He is concerned about the safety of young children walking to St Mary's School. The Parish Council shares these concerns and will send a letter of support to Nottinghamshire County Council. **Clerk/Chair to send letter**

Resident reported speeding vehicles on Swinecote Road particularly in view of the new bridleway between Thoresby Vale and Edwinstowe and fully supported the concerns about Greendale Avenue. **Clerk/Chair to send letter**

Resident reported parking on Paddock Close. **Clerk/Chair to send letter**

Resident reported parking on Fourth Avenue around school pick up/drop off. **Clerk/Chair to send letter.** (There was provision in the NCC capital programme for double yellow lines on Fourth and Fifth Avenue) **Clerk to follow up**

Resident queried when a decision would be made about the toilets on Mansfield Road toilets. **This is an agenda item**

iv. Hanging Baskets/Watering

The Finance and Governance Committee proposed employing a seasonal worker for 20 hours per week from 1st June to 30th September to assist with watering the hanging baskets and planters. The cost (including on costs) will be approximately £6k.

Cllr J Peck proposed and Cllr Carlton seconded. Approved unanimously

v. Memorial Wood – Update

The wood at the top of the cemetery is owned by Thoresby and rented to Sherwood Forest Trust. The lease has expired. Sherwood Forest Trust to follow up and liaise with the Clerk.

25/104 Buildings & Facilities

i. Fourth Avenue Bowls Pavilion and Disused Bowling Green Update

The pavilion and bowling green are owned by CISWO. The Parish Council lease the area but have not suitable use for it and are currently in negotiation with CISWO to surrender the lease. We are awaiting a response.

ii. Workshop/Store

Clerk is meeting with Robin Hood Colts regularly and an area of land has been identified. Quotes for necessary groundworks, a new container and fencing are currently being obtained. This would be funded by s106 monies.

iii. Mansfield Road Toilets

The toilets have been closed since before COVID – for around 6 years.

Options available are: -

- Do nothing
- Refurbish the old toilet block (cost approx £60K)
- Demolish the old block and landscape the area into a community garden. The disabled toilet would be renovated and would be open during the day until 3.00pm when they would be accessible by RADAR key.

Planning permission is not required to demolish the old toilet block but **Clerk to check if other permissions are required.**

Cllr Brooks to check ownership of the land at NSDC.

After a lengthy discussion it was unanimously agreed to demolish the old block, landscape the area and renovate the disabled toilet. Proposed Cllr J Peck, Seconded Cllr K Peck.

iv. Memorial Bench – David & Faith Benham

The Parish Council has been approached by resident to install a memorial bench at the bottom of the High Street for David and Faith Benham.

There is a space opposite their shop where there was a bench previously. The Parish Council would install and maintain the bench and would provide a donation towards any fundraising. **Clerk to contact residents who raised the idea.**

The Chair reported the recent damage caused to a litter bin outside the library by a delivery lorry. The Clerk reported to NCC and was informed that there is no money in the budget for such repairs. The Amenity Team have replaced the bin but there is an issue with the paviours as they are uneven and a trip hazard. **Clerk to chase response from NCC**
